**SECTION 4: First aid measures**

**4.1. Description of first aid measures**

**General information**

In all cases of doubt, or when symptoms persist, seek medical advice. In case of unconsciousness give nothing by mouth, place in recovery position and seek medical advice.

**In case of inhalation**

**7.1. Precautions for safe handling**

**Advices on safe handling**

If the formation of dust is beyond the occupational exposure limit values, approved and suitable respiratory protection must be used. Lighting and other electric equipment must be explosion protected in order to avoid hot surfaces, sparks and other ignition sources. Product may become electrostatically charged. Provide earthing of containers, equipment, pumps and ventilation facilities. Keep away from heat sources, sparks and open flames. Avoid contact with skin, eyes and clothes.
